The site is an eyesore in the centre of the village.</li> <li>2. The site has been a source of constant complaint to the Community Council over the years. However, despite having reported these problems to Isle of Anglesey County Council, no action has been taken and the site has been allowed to deteriorate further.</li> <li>3. The development of the site will not only improve the amenity of the area but will provide four new quality homes, which will be energy efficient and one of whom is to be an affordable dwelling.</li> <li>4. In the history of local community councillors, there has been no flooding issue on the site. The flood-gates at Valley Cobb are regularly maintained and inspected and therefore the risk of these failing is very small.</li> <li>5.
