3	<p>Trafodaethau gyda Chlybiau Pel Droed</p> <p>Adroddodd Mr Williams fod trigolion yn defnyddio meysydd 1 a 2 ar gyfer “kick abouts” ac yn dinistrio yr ardal o flaen y gol. Gofynnodd i'r Cyngor Cymuned gysidro gosod un postyn ar maes 3 gan obeithio y byddai pobl sydd angen “kick-about” yn ei ddefnyddio yn lle meysydd 1 a 2. Gofynnodd hefyd i osod arwydd i'w cyfeirio at maes 3. Fe fyddai Mr Williams yn fodlon torri'r gwair ar maes 3 yn rhad ac am ddim.</p> <p>Cytunnwyd i gysidro'r mater a chael pris am osod un post ar maes 3, gyda'r bwriad o roi cynnig ymlaen am gyllideb yn 2021/22. Byddai hefyd angen cysidro y byddai'r Cyngor Cymuned yn gyfrifol am sicrhau ei fod yn saff o ochr iechyd a diogelwch.</p>	<p>Discussions with Football Clubs</p> <p>Mr Williams reported that residents were using pitches 1 and 2 for “kick-about” and destroying the area in front of the goal. He asked the Community Council to consider erecting one post on pitch 3 in the hope that persons would use this area rather than pitches 1 and 2. He requested that signs be erect to signpost them to pitch 3. Mr Williams would be willing to cut the grass on pitch 3 free of charge.</p> <p>It was resolved to consider the matter and obtain a price for erecting one post on pitch 3, with the intention of putting a bid forward for funding in 2021/22. Consideration would also have to be given to the fact that the Community Council would be responsible for ensuring it was safe from a health and safety perspective.</p>

It was resolved to ask the local PCSO to monitor the situation.</p> <p>A question was asked as to whether it would be possible to close the gates at night but this had been discussed previously and no-one was available to do this regularly.</p> <p>Brambles behind the pavilion – these were over-grown and it was requested that the be cut back. Clerk to arrange.</p> <p>Covid 19 – football. Mr Williams reported that the Junior Football Club would not be using the pavilion and there was some doubt as to whether the Senior Football Club would play this year.
