Disgwylir i'r cynrychiolwyr ieuencid ddefnyddio cyfryngau cymdeithasol er hysbysu a chynnal diddordeb pobl ifanc yng ngwaith a penderfyniadau'r Cyngor sydd yn effeithio ar eu hardal. Rhagdybir bydd y cynllun cynrychiolwyr ieuencid yn help i hyder person ifanc, cynyddu ei wybodaeth am ddemocratiaeth leol, dinasyddiaeth, ac ehangu eu CV gan obeithio byddai hyn yn cynyddu eu siawns o well cyflogaeth neu gyfleoedd addysgol yn y dyfodol.

Are you a young person between 16 and 22 with an interest in your area?

Valley Community Council are looking to appoint up to two youth representatives to represent the interests of young people on the council, who live, work or receive their education or training in the community area.

The purpose of youth representatives on the Council is to obtain their views and opinion on local matters within their area. This in turn will give them the responsibility of planning for local services which affects all of us now as well as in the future. It is necessary for the youth representative to attend meetings of the Community Council which are held on the third Wednesday of every month, currently on Zoom. The agenda will be published on the Community Council website on the preceding Thursday.

They will be taking part in discussions relating to Council matters thus ensuring the views of the young are considered before the Council reaches its decision. It is expected that youth representatives will use social media to promote and seek the interest of young persons in the council's decisions which affects their area. It is envisaged being a youth representative would help the confidence of young persons, increase their knowledge on local democracy, citizenship and would also add to their CV, which hopefully would lead to better employment opportunities or better educational opportunities in the future.

This is a great opportunity for a person who has an interest in their community or wishes to have an input into local politics.

The youth representative will not have any legal responsibility for any decision made by the council neither will be taking part in any voting.
