Review Terms of Reference  The Terms of Reference for the Parks Committee was reviewed.  Point 3 – Coun. Dillon James Hughes agreed to undertake regular checks of the play equipment in the play area by the school and to report any potential risks/defects at the monthly Council meeting.  Point 8 – That the Council agree to reducing the number of committee meetings annually to three.  Point 9 – That the Council consider reducing the number of members on the Parks Committee from five to four, to be effective from the next Annual Meeting in May 2023.  Point 9 – As the vice chair is not a member of the committee, recommend that the automatic inclusion of the vice chair on the Parks Committee be removed from the terms of reference and approved by the Council
