Fodd bynnag, argymhellir na ddylid trosglwyddo hyn nes y rhagwelir arian cario ymlaen diwedd blwyddyn yn fwy cywir. • Gellir talu costau cyfieithu / Zoom o'r arian wrth gefn. <p>Wrth osod y gyllideb, neilltuwyd swm o £9977 ar gyfer ei gario ymlaen i 2021/22 a gostyngwyd y praecept i adlewyrchu hyn.</p> <p>Y gwir gario ymlaen o 20/21 oedd £12816 Yn realistig mae'n rhy fuan i ragweld yn gywir gan nad yw'r mwyafrif o wariant y flwyddyn wedi digwydd eto.</p>	<p>Overview</p> <ul style="list-style-type: none"> • Contingencies – this is funding set aside for emergencies during the year which have not been budgeted for. • Play area repairs – The predicted expenditure will not happen this year but will need to be considered for next year's budget. • Overspend in clock and bus shelter, is actually allowed for in the earmarked reserves account. However, it is recommended that this is not transferred over until a more accurate year end carry forward is forecast. • Translation/Zoom costs can be covered from the contingency. <p>When setting the budget a sum of £9977 was set aside for predicted carry forward into 2021/22 and the precept was reduced to reflect this.</p> <p>Actual carry forward from 20/21 was £12816. Realistically it is too soon to accurately forecast as the majority of the year's expenditure has not yet happened.</p>
