2	<p>Cyflwyniad a throsolwg o gyfnod adroddiad monitro'r Gyllideb 1.4.22 – 30.06.22</p> <p>Roedd y clerc wedi dosbarthu'r adroddiad monitro chwarterol ar gyfer cyfnod 1 a oedd yn cynnwys y rhagolwg cyllideb ar gyfer 2022/23.</p> <p>Argymhelliad 1: Derbyn yr adroddiad monitro cyllideb fel adlewyrchiad gwir a chywir o sefyllfa ariannol y Cyngor.</p> <p>(Prop NT/Sec GB)</p> <p>Roedd y clerc wedi ymweld â'r platfform ym Mharc Mwd gyda'r Cynghorydd I Jones, Cadeirydd Pwyllgor Parc Mwd, gan fod y platfform wedi ei nodi fel risg ar asesiad ROSPA. Mae'r platfform mewn cyflwr gwael ac mae'r rheiliau diogelwch yn ildio. Yn wyneb yr uchod, argymhellwyd tynnu'r platfform gyda rhai llwyni/coed yn cael eu plannu yn yr ardal er mwyn gorchuddio'r llwybr naturiol. Derbyniwyd amcangyfrif o £350 ynghyd â chost unrhyw goed. Awgrymwyd clirio hwn ar yr un pryd.</p>	<p>Presentation and overview of Budget monitoring report period 1.4.22 – 30.06.22</p> <p>The clerk had circulated the quarterly monitoring report for period 1 which included the budget forecast for 2022/23.</p> <p>Recommendation 1: To accept the budget monitoring report as a true and accurate reflection of the Council's financial position.</p> <p>(Prop NT/Sec GB)</p> <p>The clerk had visited the platform in Parc Mwd with Coun I Jones, Chairman of the Parc Mwd Committee, as the platform had been noted as a risk on the ROSPA assessment. The platform is in poor condition and the safety railings are giving way. In view of the above, it was recommended that the platform be removed with some shrubs/trees planted in the area in order to cover the natural pathway. An estimate had been received in the sum of £350 plus the cost of any trees. An allowance of £1000 had been put in the budget for any works associated with the ROSPA assessment. It was also noted that a tree had fallen and was crossing one</p>
