Bydd y ffigwr hwn yn cynyddu ym mis Hydref pan fydd cost trydan i godi unwaith eto.</p> <p>Byddai'n rhaid felly ariannu unrhyw benderfyniad i dorri'r llwyni a'r coed yn y triongl o'r gronfa wrth gefn.</p> <p>Felly byddai unrhyw brosiectau newydd a gymeradwyir ar gyfer Parc Mwd angen ffynhonnell arall o gyllid, e.e. ar ffurf grantiau neu'n rhan o gynllun tymor hwy ar gyfer datblygu'r parc.</p>	<p>Budget and expenditure 2022/23</p> <p>The clerk reported that the budget allocated for Parc Mwd was forecasted to be £1104.95 over-spent by the end of the financial year and a projected £2254.99 if the contingency allowance of £500 and balance from the funding set aside for ROSPA repairs was utilised. This figure will increase in October when the cost of electricity is set to rise once again.</p> <p>Any decision to cut back the shrubs and trees in the triangle would therefore have to be funded from the contingency fund.</p> <p>Any new projects approved for Parc Mwd would therefore require an alternative source of funding, e.g. in the form of grants or form part of a longer term plan for the development of the park.</p>

This is inset in concrete and costs could be high due to this.</p> <p>c) Sourcing an individual/company to propose some alternative options to the wooden boundary edging, preparing a detailed schedule of works for removal and replacement with a suitable alternative, which would enable the Community Council to go out to tender. Councillor K Taylor to make tentative enquiries and report to full Council meeting. Clerk will also enquire as to suitable companies to undertake this work.</p>
4.2	<p>Rhwyd Pel Fasged</p> <p>Roedd pobl ifanc lleol wedi ysgrifennu at y Cadeirydd yn gofyn i'r Cyngor Cymuned ystyried gosod rhwyd pêl-fasged ym Mharc mwd. Roedd trefniadau wedi eu gwneud i gwrdd â'r bobl ifanc hyn yn ystod y Diwrnod Hwyl ym Mharc Mwd ar 20fed Awst, gyda golwg ar sefydlu a fyddent yn fodlon helpu i godi arian ar gyfer hyn ac i drafod eu gofynion ymhellach.</p> <p>Roedd y clerch wedi cael amcangyfrif o £2825 ynghyd â TAW ar gyfer cyflenwi a chodi rhwyd pêl-fasged galfanedig. Nid oedd hyn yn cynnwys gwaith daear. Dywedodd y Cynghorydd Taylor wrth y cyfarfod ei fod yn dilyn llwybr i gwrdd â'r gost ac y byddai'n adrodd yng nghyfarfod llawn y Cyngor.</p> <p>Cytunwyd y byddai angen nodi lleoliad addas pe byddai'r prosiect yn mynd rhagd</p>	<p>Basketball net</p> <p>Local youths had written to the Chairman requesting the Community Council to consider putting up a basketball net in parc mwd. Arrangements had been made to meet with these youths during the Fun Day in Parc Mwd on 20th August, with a view to establishing whether they would be willing to help to raise funds for this and to discuss their requirements further.</p> <p>The clerk had obtained an estimate of £2825 plus VAT for supply and erection of a galvanised basketball net. This did not include groundworks. Councillor Taylor informed the meeting that he was pursuing an avenue to meet the cost and would report at the full Council meeting.</p> <p>It was agreed that a suitable location would need to be identified in the event that the project proceeds.</p>

These should be costed, in order to forecast when they were likely to be undertaken and how they could be funded, bearing in mind that most grant applications required some element of financial contribution from the Community Council's budget.
