RHODDIR DRWY HYN RYBUDD fod Cyngor Sir Ynys Môn/Isle of Anglesey County Council yn bwriadu dim llai na saith niwrnod ar ôl dyddiad y rhybudd hwn wneud Gorchymyn bydd yn gwahardd dros dro pob cerbyd, ac eithrio cerbydau arfwng, rhag teithio mewn unrhyw gyfeiriad ar hyd y ffordd tu allan i 25-27 Bryn Moryd, Valley.

Mae angen y Gorchymyn i adnewyddu polyn diffygiol a gweithgareddau ceblau ar ran Openreach.

Y ffordd arall fydd o ben gogledd ddwyreiniol y caead y tu allan i Rif 27, Bryn Moryd. Teithio mewn cyfeiriad de dwyreiniol i'r gyffordd gyda Lôn Gorad a throi i'r dde. Teithio i gyfeiriad y de orllewin ar hyd Lôn Gorad i'r gyffordd â Bryn Moryd a throi i'r dde. Dilyn y ffordd o gwmpas i Rif 25, Bryn Moryd a phen arall y cau ffordd. I'r gwrthwyneb ar gyfer traffig sy'n teithio o'r cyfeiriad arall.

Daw'r Gorchymyn i rym ar 24ain Awst 2022 a bydd yn parhau mewn grym am gyfnod na fydd yn fwy na 4 wythnos neu hyd nes y cwblheir y gwaith y bwriedir ei wneud ar y ffordd, pa un bynnag fyddo gyntaf. Ar hyn o bryd disgwylir i'r gwaith gael ei gwblhau ar 24ain Awst 2022.

NOTICE IS HEREBY GIVEN that Cyngor Sir Ynys Môn/Isle of Anglesey County Council intend not less than seven days from the date hereof to make an Order, the effect of which will temporarily prohibit all vehicles, except for emergency vehicles, from travelling in either direction along the road outside 25-27 Bryn Moryd, Valley.

The Order is necessary to renew a defective pole and cabling activities on behalf of Openreach.


The alternative route will be from north eastern end of the closure outside No. 27, Bryn Moryd. Travel in a south easterly direction to the junction with Gorad Road and turn right. Travel in a south westerly direction along Gorad Road to the junction with Bryn Moryd and turn right. Follow the road around to No. 25, Bryn Moryd and the opposite end of the road closure. Vice versa for traffic travelling from the opposite direction.

The Order comes into effect on 24th August 2022 and will continue in force for a period not exceeding 4 weeks or until the work which it is proposed to carry out on the road is completed, whichever is the earlier. At this stage it is anticipated that the works will be completed on 24th August 2022.
