Efallai y bydd gostyngiad hefyd yng nghost wirioneddol lwfansau aelodau, er bod hyn yn dibynnu ar y nifer sy'n</p>	<p><b>Presentation of Budget monitoring report period 1.4.22 – 30.09.23</b></p> <p><b>Enclosure</b>                  Cash book April 22 – March 23                  Quarterly Monitoring Report for period 2</p> <p>The clerch presented the aforementioned documents and noted that since the report had been written, Isle of Anglesey County Council had confirmed that 50% of the current fee, without the additional of inflation, would be charged for the car park agreement for this year as part of it was closed for a period of time in order for it to be used as a compound for the contractors working on the flood alleviation project in the village. A revised cash book was presented to include this amendment. This reduction had resulted in a projected carry forward to 2023/24 of £3310.87 which was acceptable as the budgeted carry forward was £3000. There may also be a reduction in the actual cost of members allowances, although this was dependent on take-</p>

The report received from G L Jones states that there is significant corrosion to the equipment and therefore it is absolutely essential that the Community Council develops a plan for future replacement of this.</p> <p><b>Recommendation 5:</b> That the clerk prepare a stand-still budget, i.e. maintaining existing provision/service with a 15% allowance for inflation. Bydd y clerc yn ceisio cael eglurhad a yw'r opsiwn hwn yn parhau i fod ar gael.</p> <p>b) Gosod taliad ar gyfer nwyddau traul</p> <p>Rhaid i gynghorau naill ai dalu £52 y flwyddyn i'w haelodau am gost nwyddau traul swyddfa sydd eu hangen i gyflawni eu rôl, neu fel arall rhaid i gynghorau alluogi aelodau i hawlio ad-daliad llawn am gost nwyddau traul eu swyddfa.</p> <p>Bydd Cyngor Cymuned y Fali yn talu pan gyflwynir derbynneb ddilys.</p>	<p><b>Independent Remuneration Panel for Wales Draft Annual Report - February 2023</b></p> <p>The draft report has been circulated to members and comments should be submitted by 1<sup>st</sup> December 2022. Valley Community Council is in Band 4 and the recommendation for this band is as follows:-</p> <p>a) Basic payment for extra costs of working from home (currently the members allowance) -</p> <p>All councils must pay their members £156 a year (equivalent to £3 a week) towards the extra household expenses (including heating, lighting, power and broadband) of working from home.</p> <p><b>Note:</b> This is currently payable at £150 but members may exercise their right to decline the allowance. The clerk will seek to clarify whether this option remains available.</p> <p>b) Set payment for consumables</p> <p>Councils must either pay their members £52 a year for the cost of office consumables required to carry out their role, or alternatively councils must enable members to claim full reimbursement for the cost of their office consumables.</p> <p>Valley Community Council will pay on presentation of a valid receipt.</p>
