Mae hwn yn nodi'r canlynol:</p> <ul style="list-style-type: none"> <li>• Rhagamcan o orwariant yng nghyflog y Clerc. Mae hyn oherwydd bod yr adolygiad cyflog ar gyfer 2021/22 wedi'i gwblhau ym mis Mawrth 2022. Talwyd y codiad cyflog ar gyfer 2022/23 ym mis Rhagfyr, wedi'i ôl-dalu i 1 Ebrill 2022. Fel arfer byddai cyflog y cleric ar gyfer mis Mawrth yn cael ei dalu ym mis Ebrill ond, fel y cytunwyd yng nghyfarfod llawn y Cyngor a gynhalwyd ym mis Chwefror, mae cyflog mis Mawrth wedi'i dalu ym mis Mawrth, ynghyd â chyflog ar gyfer mis Chwefror. Bydd gostyngiad mewn gwariant ar gyflogau clerciaid yn 2023/24 oherwydd hyn.</li> <li>• Mae GL Jones wedi cwblhau'r gwaith adnewydd yn y maes chwarae ac fe fydd yr anfoneb yn cael ei thalu mis Mawrth.</li> <li>• Mae'r Iwfans ar gyfer gwariant a ragwelir o £500 ar y llochesi bysiau wedi'i symud o'r gyllideb gan ei fod yn annhebygol o gael ei wario yn 2022/23. Mae swm wedi'i roi yn y gyllideb ar gyfer 2023/24 er mwyn tacluso'r llochesi bws presennol ond bydd angen gwneud penderfyniad ynghŷn â'r lloches bws gyferbyn â Gwesty'r Fali. Dylid cysylltu ag Adran Briffydd Cyngor Sir Ynys Môn yn y flwyddyn ariannol newydd er mwyn canfod a allai unrhyw gyllid ddod ar gael i osod un newydd..</li> <li>• Bydd Ynys Wen yn gost niwtral. Bydd angen trosglwyddo cyfanswm y gost ar gyfer 2022/23 o Gyfrif Ynys Wen i Gyfrif y Trysorydd ym mis Ebrill 2023/24.</li> <li>• Mae balans rhagamcanol bychan yn y SDS a gellid defnyddio hwn i wrthbwys o rhai o'r costau ychwanegol a gafwyd yn ystod y flwyddyn.</li> <li>• Mae'r cloc yn dangos gorwariant cynyddol oherwydd cost y cyflenwad trydan a dyblu'r tâl sefydlog yn unig. Fodd bynnag, tra bod costau trydan yn parhau i godi, bydd unrhyw gymorth ariannol gan y</li> </ul>	<p>3. Pages 4 and 5 gives an overview of budget outlook and this is updated monthly and provided to the Finance Committee quarterly. This notes the following:</p> <ul style="list-style-type: none"> <li>• A projected overspend in Clerk's salary. This is because the salary review for 2021/22 was concluded in March 2022. The salary increase for 2022/23 was paid in December, back paid to 1<sup>st</sup> April 2022. The clerk's salary for March would normally be paid in April but, as agreed at the full Council meeting held in February, the March salary has been paid in March, together with salary for February. In view of this, there will be a reduction in clerk salary spending in 2023/24.</li> <li>• G L Jones have now completed the repairs to the play area and the invoice will be paid in March.</li> <li>• The £500 allowance for projected expenditure on the bus shelters has been removed from the budget as it is unlikely to be spent in 2022/23. A sum has been put in the budget for 2023/24 to allow for some tidying up of the existing bus-shelters but a decision will still need to be made on the bus shelter opposite the Valley Hotel. Isle of Anglesey County Council's Highways Department should be contacted in the new financial year to establish whether any funding may become available to replace this.</li> <li>• Ynys Wen will be cost neutral. The total cost for 2022/23 will need to be transferred from the Ynys Wen Account to the Treasurers Account in April 2023/24.</li> <li>• There is a small projected balance in the SDS and this could be used to offset some of the additional costs incurred during the year.</li> <li>• The clock shows an increasing overspend solely due to the cost of the electricity supply and the doubling of the standing charge.</li> </ul>

	<p>Llywodraeth yn gwrthbwys o'r gorwariant yn y gyllideb hon oherwydd y cynnydd yng nghostau trydan yn ystod y flwyddyn. Dylai hyn gael ei adlewyrchu yn y bil neu'r datganiad nesaf.</p> <ul style="list-style-type: none"> <li>Mae'r cyfanswm TAW eleni yn sylweddol uwch na'r disgwyl yn bennaf oherwydd bod y contractor cynnal a chadw tir yn cofrestru am TAW ar ôl i'r gyllideb gael ei gosod. Y swm TAW a ragwelir oedd £1838 pan yn gosod y gyllideb, one disgwyliwyd gwariant rhagamcanol o £4006. Mae'n bwysig nodi felly bod hyn wedi cael effaith sylweddol ar ein arian fydd yn cael ei gario ymlaen ar gyfer 2023-24 ond bydd yn cael ei adfer ar ddiwedd y flwyddyn ariannol hon a'i ychwanegu at gyllideb 2023-24.</li> <li>Caniateir balans i'w gario drosodd o gyllideb 2022/23 ar gyfer 2023/24 o £3000. Yn seiliedig ar y gwariant a ragwelir ar hyn o bryd, rhagwelir y bydd hyn yn awr yn £3778.24 sydd yn ôl ar y trywydd iawn.</li> </ul>	<p>However, whilst the electricity costs continue to rise, any Government funding support will offset some of the overspend in this budget due to the increased cost of electricity during the year. This should be reflected in the next bill or statement.</p> <ul style="list-style-type: none"> <li>The VAT total this year is significantly higher than anticipated mainly due to the ground maintenance contractor becoming VAT registered after the budget had been set. The projected VAT amount was £1838 when setting the budget, versus a projected total cost of £4006. It is therefore important to note that this has had a significant impact on our predicted carry-forward for 2023-24 but it will be recovered at the end of this financial and added to the 2023-24 budget.</li> <li>The predicted carry forward allowed for in the 2022/23 budget for 2023/24 is £3000. Based on current predicted expenditure this is now projected to be £3778.23 which is back on track. The clerk predicts that the outturn may be better than this taking into account the following.</li> </ul>
