All issues raised from last assessment have been addressed. <u>Item 6.</u> Builders using cemetery car park to clean vehicles: It was noted that no recent reports had been received in this respect.

Roedd yr ymgymwrwr	Condition of new graves A complaint was received from a member of the public late on 19.04.23 regarding the condition of a new grave. The soil had settled and the grave appeared sunk. The undertaker involved rectified

It was reported that that particular area of the cemetery becomes extremely wet especially during winter months. Good practice was noted by some undertakers, where additional graves were opened, bricked up and refilled in advance, thus reducing the traffic of machinery on the land. Some soil also placed in a mound on the grave after interment to allow for settlement. Boards are also put down to reduce damage to the field. Recommendation 1: To add 'the condition of the cemetery field' to the Risk Assessment and to seek advice from the Local Authority on potential drainage solutions and continued safe use of the burial area. All agreed. The Clerk to contact the Local Authority as soon as possible.

Prop/Sec MSW/NT	Burial Fees The balance of the Ynys Wen accounts was noted at £27,231.09 at 31.03.23. The income generated during 2022/23 was £7,110. Maintenance costs were £1,682.73 for the period. The number of burials increased during the year i.e., 11 opening of graves, 9 re-opening of graves plus 6 burial of ashes, compared to 9,1 and 1 respectively during 2021/22. Sufficient capacity for burial at the site was noted. The burial fees were reviewed and it was recommended that they remain the same. Recommendation 2: That burial fees to remain the same.
