The projected costs to be £1,614.65 for 2023/24, i.e. electricity £1,154.28, water £155.42 and council tax £304.95. The above lease holders being the main users of the park. She also demonstrated the smart meter electricity readings for the last three years.</p> <p>She confirmed that the 2023/24 maintenance budget for Parc Mwd is £14,694 and has projected a £177 overspend by the year end based on current essential repairs commitment. The budget excludes any development costs.</p> <p>The clerk reported that advice from One Voice Wales included <i>the renewal of the leases in 3 years' time will give the Council the opportunity to review utility payments in any new lease</i>. It is understood that the Senior Football Team had folded with the Junior football team is seeking to take over both leases and Valley Community Group lease is due or renewal now.
