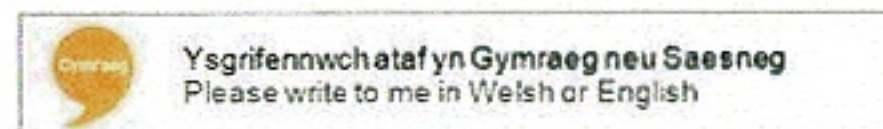



Y ffordd arall fydd o ben deheuol y cau ffordd. Teithiwch i gyfeiriad y gogledd orllewin ar hyd y B5109 o Fodedern i Lanynghenedl a throwch i'r dde ar yr A5025. Teithiwch i gyfeiriad y gogledd ar hyd yr A5025 i Lanfachraeth a throwch i'r dde i Lôn Mynydd-yr-Eithin. Teithiwch mewn cyfeiriad gogledd dwyreiniol ar hyd Lôn Mynydd-yr-Eithin i'r gyffordd â Lôn Plas Llanfigael a throwch i'r dde. Teithio i gyfeiriad deheuol ar hyd Lôn Plas Llanfigael i ben arall y ffordd sydd ar gau. I'r gwrthwyneb ar gyfer traffig sy'n teithio o'r cyfeiriad arall.

Daw'r Gorchymyn i rym ar 22ain Awst 2023 a bydd yn parhau mewn grym am gyfnod na fydd yn fwy na 6 wythnos neu hyd nes y cwblheir y gwaith y bwriedir ei wneud ar y ffordd, pa un bynnag fyddo gyntaf. Ar hyn o bryd disgwylir i'r gwaith gael ei gwblhau ar 24ain Awst 2023.

NOTICE OF INTENTION

ROAD TRAFFIC REGULATION ACT, 1984 SECTION

NOTICE IS HEREBY GIVEN that Cyngor Sir Ynys Môn/Isle of Anglesey County Council intend not less than seven days from the date hereof to make an Order, the effect of which will temporarily prohibit all vehicles, except for emergency vehicles, from travelling in either direction along Lôn Plas Llanfigael, Bodedern.

The Order is necessary to enable renewal of a defective pole and cabling activities on behalf of Openreach.

The alternative route will be from the southern end of the road closure. Travel in a north westerly direction along the B5109 from Bodedern to Lanynghenedl and turn right onto the A5025. Travel in a northerly direction along the A5025 to Lanfachraeth and turn right onto Lôn Mynydd-yr-Eithin. Travel in a north easterly direction along Lôn Mynydd-yr-Eithin to the junction with Lôn Plas Llanfigael and turn right. Travel in a southerly direction along Lôn Plas Llanfigael to the opposite end of the road closure. Vice versa for traffic travelling from the opposite direction.

The Order comes into effect on 22nd August 2023 and will continue in force for a period not exceeding 6 weeks or until the work which it is proposed to carry out on the road is completed, whichever is the earlier. At this stage it is anticipated that the works will be completed on 24th August 2023.
