The Chairman thanked the organisers of the Remembrance Service on Sunday the councillors who attended. He noted that their efforts not only paid tribute to the courage and selflessness of our soldiers but also provide a meaningful space for the community to come together to reflect and give thanks. He expressed that the dedication of the organisers to ensure the seriousness and dignity of the occasion deserves praise, as they have undoubtedly contributed to fostering a sense of remembrance and collective gratitude within the community. The Chairman reported that there was a requirement to proceed with the council's objectives on how to communicate and consult with the community. A working group has already been formed and this will meet in early January to draw up plans on how our council can move forward with this objective. Members were advised that Scottish Power has finally, traced the root cause of all the recent power outages on Lon Gardner, to an underground fault at the substation there. The fault is now repaired and the groundworks is on going to make good the pavement at the site.
