The Local Authority's current financial position and budget setting timeframe was acknowledged.</p> <p>The Finance Committee made the following recommendations to the Council:</p> <p><b>Recommendation 1:</b> That the Community Council set a precept of £46,963.55 which remains the same as per the 2023/24 precept. This will ensure that we can meet an estimated increase of 7% inflation on existing commitments and maintain a breakeven budget for 2024/25.</p> <p>This is based on a predicted total budget</p>
