Ffurflen Gais, Nodiadau Cyfarwyddyd i Ymgeiswyr, Telerau ac Amodau Rhodd, Ffurflen Derbyn Rhoddion a Matrics Gwerthuso. Rhoddodd y cleric wybod am y pŵer Adran 137 sydd ar gael i'r cyngor a'r uchafswm y gellid ei ddyfarnu yn ystod y flwyddyn ariannol Mae'r polisi yn cynghori ar yr uchafswm o rodd sy'n daladwy o ystyried bod y gyllideb o £600 eisoes wedi'i gosod ar gyfer 2024/25. Gwahoddir ceisiadau erbyn 30 Tachwedd bob blwyddyn ar gyfer dyfarnu'r flwyddyn ariannol ganlynol. Bydd lefel y dyfarniad rhodd yn cael ei adolygu bob blwyddyn yn ystod y broses o bennu'r gyllideb. Mae gan y Cyngor ddisgresiwn i ystyried achosion brys yn ystod y flwyddyn. Dywedodd y Clerc hefyd fod y polisi yn y dyfodol yn profi gallu'r Cyngor i gynyddu lefel y rhoddion fel mae'r gyllideb yn caniatáu o flwyddyn i flwyddyn.</p>	<p>Review of Donations Policy The Clerk presented the revised policy along with the 5 new appendices i.e. Application Form, Guidance Notes for Applicants, Donation Terms and Conditions, Donations Acceptance Form and Evaluation Matrix. The clerk advised of the Section 137 power available to the council and the maximum amount that could be awarded during the financial year. The policy advises of the maximum donation payable given the budget of £600 is already set for 2024/25. Applications will be invited by 30th November each year for award the following financial year. The level of donation award will be reviewed each year during the budget setting process. The Council has discretion to consider urgent cases during the year. The Clerk also advised that the policy future proofs the Council's ability to increase the level of donations as the budget allows year on year.</p>

Members advised caution when receiving multiple applications from organisations for different projects. The Donations Policy to be promoted on the website and to all local organisations who regularly access support from the Council.</p> <p>Recommendation 1: For the Council to agree the maximum donation payable during 2024/25 per application, e.g. £50 per application will help 12 organisations; £75 per application will help 8 organisations; - £100 per application will help 6 organisations etc.</p> <p>Recommendation 2: The Council approve the Donation Policy version 3 February 2024.</p> <p>Recommendation 3: The Council approve for the Donations Policy to be promoted on the website and to all local organisations who regularly access support from the Council.</p>

It was agreed that the cost of the remembrance wreaths would not be included in the donation calculation as it was felt these needed to be purchased for the memorial services. Therefore, a balance of £50 remains available to donate in 2023/24.</p> <p>Six applications await determination. The clerk would prepare the evaluation matrices for each application before the next Council meeting.</p> <p>Recommendation 4: For the Council to determine which of applications could be supported, which could be supported in 2023/24 and which could be deferred for award in 2024/25.</p>
