He advised that Valley had been extremely fortunate to receive the funding. The grant will allow for a Zebra crossing with Belisha Beacons plus improvements to pathways around the village i.e. the repair of kerbs, drop kerbs plus renew or repair tactile paving at several key crossing areas around the village to ensure safe accessible pathways. The work will also include provision of a path in front of the corner shop at the traffic lights, enabling the pathway to be aligned with the bus stop. It is understood also that the grant will fund a bench to be located on the grass verge
