Local Community and County Councillors have reported many incidents to the Local Authority Highways Department, North Wales Police and to Local Members of Parliament. The Head of the Highways Department has assured the Community Council that the Local Authority will impose as much enforcement as possible and reasonable within their resources. The Chair also confirmed that he had written to North Wales Police Chief Constable Amanda Blakeman and to the Office of the Police and Crime Commissioner regarding these parking problems on 28th March 2024.
