Members expressed confusion as it was understood that the lease for the football field is currently with the Valley Juniors Club. The Clerk confirmed her understanding that the teams are governed by one committee of which Mr Dan Jones, the applicant, is the Chairman. She also confirmed that the lease is to be reviewed before August 2025. Members observations included that the park falls within the AONB (Area of Outstanding Natural Beauty) and the duty that places on the council to protect the area. In addition any signage over 0.3m ² surface area in an AONB would require planning permission. Concerns were raised over the extent of vandalism currently endured at Parc Mwd around the park and pavilion, including to the football dugouts.
