1. Introduction

Welcome to Valley Community Council Annual Report for the 2024/25 financial year. The Council is pleased to celebrate 50 years since it was established in 1974.

This report has been prepared as a direct requirement of the Local Government and Elections (Wales) Act 2021 which aims to ensure sound governance an effective management of public money. The report intends to increase the transparency and awareness of the work of the community council.

2. The Council

Valley Community Council is a small body of 13 volunteer councillors, who work towards enhancing and maintaining our communities. Our wards cover the West and the central Village of Valley plus Gorad and Llanynghenedl. The clerk is the only employee.





5. Financial Information

A summary of the council's financial position at the end of 2024/25 financial year is given below:


Income:

The Council received a Precept of £46,964 from the Local Authority, other income of £21,149 plus an additional £55,500 in grant funding to deliver its services for 2024/25 as shown in the chart below.



Expenditure:

The total expenditure during 2024/25 was £131,476 as shown in the chart below.

6. Relationship with the Local Authority

The Council has worked closely with the Bro'r Llynnoedd County Councillors during the year. Both County Councillors Ken Taylor and Gwilym Jones attend the Council's monthly business meetings. Councillor Ken Taylor has also been a County and Community Councillor for many years. Information is always cascaded via the Chair of the Council and the clerk. Representatives have attended all the Town and Community Council Liaison Forum meetings with the Authority and provided updates to each of the following Community Council meetings. Issues raised by Councillors relating to Local Authority responsibility are escalated to appropriate officers within the Authority for resolution.

All recommendations made in relevant reports produced by the Local Authority Standards Committee in relation to town and community council audits have been implemented.

7. Training

A training plan for the Council has been adopted reflecting the individual needs of Councillors. All Community Councillors attend training courses as appropriate. One Voice Wales provides regular training sessions for community councillors to support them in their role.

8. Complaints

No official complaints were received about the work of the Community Council during the year.

9. Achievements and Activities during 2024/25

The Council provided services and maintained the following assets for the community:

The 20.3-acre park at Parc Mwd and pavilion

The Council worked in partnership with the Bro Llynnoedd Alliance and succeeded to attract over £45,500 in grants to Parc Mwd. The funding was for repairs and improvements of the triangle area, provision of outdoor gym equipment and a basketball court. A further award in terms of trees, plants and equipment valued at over £9,000 was received from Keep Wales Tidy through the Places for Nature scheme.

The Triangle: £7,500 was received towards the repairs to the triangle perimeter and to install out door gym equipment.



Places for Nature at Parc Mwd

The Places for Nature Scheme from Keep Wales Tidy helped to improve the parks' biodiversity, to replace dead and fallen trees and provide a green space for residents' wellbeing.







VouInteers planted 115 trees (apple, pear, plum, beech, hawthorn, hazel) native bulbs and wildflower meadow turf around the park. Raised borders erected and planted with grasses, native flowers and herbs.











The Council also received equipment from Keep Wales Tidy to become a litter-picking hub for the community.

You Said, We Listened! - New facility at Parc Mwd

Following a request and wide consultation the Basketball Court at Parc Mwd was built and launched on 24th May 2025. Grants amounting to £38,000 were received towards the cost of the work i.e. £20,000 Awards for All from the National Lottery for Wales, £10,000 from Anglesey Charitable Association, £5,000 from Welsh Water and £3,000 from the Bro Llynnoedd Alliance. Lagan Aviation Infrastructure Limited provided all the ground works for the project free of charge as a benefit to the Valley Community.



Ynys Wen Public Cemetery and maintenance of burial records

The council commissioned a drainage report on the cemetery field as part of the work to review the burial capacity.

- Lease the play area nr the School from the Local Authority and maintain the play equipment and pay for refuse collection at the site
- Carried out condition surveys and risk assessments on all play equipment in the community to ensure health and safety





During the year the Council installed outdoor equipment for the children in the play area.

The Council replaced a picnic bench at Parc Mwd and installed two new benches in the community
