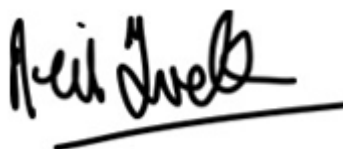

The programme includes raising awareness of Dementia making shops and public areas etc more Dementia friendly. He suggested Dementia Awareness Sessions, Dementia Friendly Signage and group activities for people living with Dementia. He stressed the importance of early diagnosis and support for those with Demetia and for their family and carers.</p> <p>The local level of need was not quantified but members were advised of the Glanhwfa Centre in Llangefni and their proposed day centre service for respite care. Access to community transport was highlighted with reference to Môn Community Transport and Car Linc Môn. Members suggested that a local dementia group could be established and suggested awareness driven forward through existing groups such as Clwb y Cob and Women's Institute etc.</p> <p>The Chair thanked Mr Geal for the information and Mr Geal left the meeting.</p> |            |

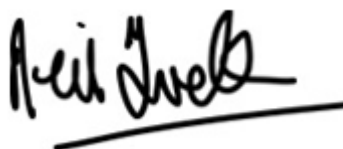

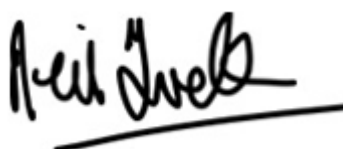
