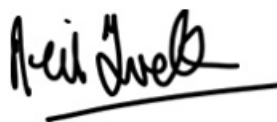

106/2526	Ynys Wen I'w ddarllen ochr yn ochr ag Achos Busnes (21.7.25) Cymeradwyo'r Achos Busnes ar gyfer Benthyciad PWLB a'i argymhellion Cyflwynodd y clerc yr achos busnes i wneud cais am fenthyciad PWLB i gwblhau'r gwaith draenio ym mynwent Ynys Wen. Yn gryno, mae'r gost a ragwelir yn seiliedig ar ddyfynbris isaf o £32,100 ynghyd â 20% wrth gefn ar gyfer costau annisgwyl oddeutu £6,420 = £38,520 Cynigiwyd defnyddio: Cronfeydd Wrth Gefn Ynys Wen £20,628 o Gronfeydd Cyffredinol £ 2,000 Benthyciad Gwaith Cyhoeddus <u>£15,000</u> <u>£37,678</u> gan ganiatáu arain argyfwng o £5,578. Byddai'r cynnig yn gadael y cronfeydd wrth gefn cyffredinol ar £20,093 neu 24.7% o'r gyllideb gyffredinol ac yn unol â chanllawiau ymarfer da. Ad-dalu'r benthyciad arfaethedig ar gyfradd sefydlog o 5.11% dros 10 mlynedd. Ad-daliad blynyddol o £1,864 i'w ariannu o ffioedd claddu lle bo hynny'n bosibl. Codwyd pryderon am y risg uchel ar arian cyhoeddus a'r ymrwymiad ariannol hirdymor. Byddai angen ystyried ymrwymadau prydles cyfredol a chynhyrchu incwm er mwyn lleihau gwariant ac osgoi unrhyw gynnydd yn y praesept. Cytunwyd nad oedd gwneud dim yn opsiwn a byddai prynu man claddu newydd y tu hwnt i fodd y cyngor ar hyn o bryd. Cyflwynodd aelod wrthgynnig i'w ystyried h.y. Cynigiwyd defnyddio: Cronfeydd Wrth Gefn Ynys Wen £20,628 o Gronfeydd Cyffredinol £ 2,000 Benthyciad Gwaith Cyhoeddus <u>£10,000</u> <u>£32,678</u> gyda'r arian argyfwng o £5,578 i'w dalu o'r cronfeydd wrth gefn cyffredinol sy'n weddill. Pe bai'r arian argyfwng yn cael ei ddefnyddio, byddai'n gadael balans wrth gefn o tua £14,515 neu 17.8% o'r gyllideb gyffredinol. Y cyngor i ailgyflenwi cronfeydd wrth gefn o'r gyllideb yn flynyddol.	Ynys Wen – To be read alongside Business Case (21.7.25) To approve the Business Case for PWLB Loan and its recommendations The clerk presented the business case to apply for a PWLB loan to complete the drainage works at Ynys Wen cemetery. In summary the anticipated cost based on lowest quotation of £32,100 plus a 20% contingency for unforeseen costs say £6,420 = £38,520 It was proposed to utilise: Ynys Wen Reserves £20,628 from General Reserves. £ 2,000 Public Works Loan <u>£15,000</u> <u>£37,678</u> allowing contingency funds of £5,578. The proposal would leave the general reserves at £20,093 or 24.7% of the overall budget and in line with good practice guidance. Repayment of the loan proposed at a fixed rate of 5.11% over 10 years. Annual repayment of £1,864 to be funded from burial fees where possible. Concerns were raised over the high risk on public money and the long-term financial commitment. Consideration would need to be given to current lease commitments and income generation in order to reduce spending and to avoid any increase in the precept. It was agreed that to do nothing was not an option and to buy a new burial area was currently beyond the means of the council. A member put forward a counter proposal for consideration i.e.: It was proposed to utilise: Ynys Wen Reserves £20,628 from General Reserves. £ 2,000 Public Works Loan <u>£10,000</u> <u>£32,678</u> with the contingency of circa £5,578 to be met from remaining general reserves. If the contingency was utilised, it would leave a general reserve balance of circa £14,515 or 17.8% of overall budget. The council to replenish reserves from the budget year-on-year.
