Trafodwyd tri opsiwn i ariannu'r gwaith draenio h.y.</p> <p><b>Opsiwn 1</b> - Defnyddio £20,628 o Gronfeydd Wrth Gefn Ynys Wen £2,000 o Gronfeydd Cyffredinol gan sicrhau bod isafswm cronfeydd wrth gefn o 24.7% yn cael eu cadw yn unol â Canllaw Ymarferwyr y Cyd-banel ar Atebolrwydd a Llywodraethu a gwneud cais am fenthyciad PWLB o £15,000 dros 10 mlynedd. Mae'r opsiwn hwn yn ei gwneud yn ofynnol i gostau annisgwyl gael eu hariannu o'r Cronfeydd Cyffredinol sy'n weddill.</p> <p><b>Opsiwn 3</b> – fel Opsiwn 2 ond gyda chyfnod addalu dros 8 mlynedd.</p>	<p><b>Ynys Wen</b>  <b>To approve the Business Case (11.8.25) for PWLB Loan and its recommendations</b></p> <p>The Chair proposed to exclude the public and press from this item as it was considered commercially sensitive. Prop/Sec: WR/CT</p> <p>The clerk presented the business case to apply for a PWLB loan to complete the drainage works at Ynys Wen cemetery. The preferred and lowest tender was confirmed as that of R G Hire at £32,100. Three options to fund the drainage works were discussed i.e.</p> <p><b>Option 1</b> - Utilising £20,628 Ynys Wen Reserves £2,000 from General Reserves ensuring minimum reserves of 24.7% are retained in line with The Joint Panel on Accountability and Governance Practitioner Guide and apply for a PWLB loan of £15,000 over 10 years. This option included a contingency included in the loan for any unforeseen costs.</p> <p><b>Option 2</b> – Utilising £20,628 Ynys Wen Reserves £2,000 from General Reserves and an application for a PWLB loan of £10,000 over 10 years. This option requires for any unforeseen costs to be funded from the remaining General Reserves.</p> <p><b>Option 3</b> – as Option 2 but with a repayment period over 8 years.</p>

<p>Nodwyd bod yr ad-daliadau benthyciad i'w hariannu o ffioedd claddu lle'n bosibl er mwyn osgoi unrhyw gynnydd yn y praesept.</p> <p>Nodwyd, er ei bod yn amhosibl rhagweld yn gywir, bod angen tua 8 claddu y flwyddyn i ad-dalu'r benthyciad. Nododd aelodau hefyd y duedd gynyddol ar gyfer amlosgi yn hytrach na chladdedigaethau. Cytunwyd bod angen adolygu'r ffioedd claddu yn unol â gosodiad y gyllideb a bod yn rhaid ystyried holl rwymedigaethau eraill y cyngor. Cyngorodd y clerc bwysigrwydd adolygu'r holl asedau, gosod cynlluniau cynnal a chadw priodol wrth osod y gyllideb flynyddol gan gynnwys swm wrth gefn yn y gyllideb i sicrhau bod lefel briodol o gronfeydd wrth gefn ar gael i liniaru unrhyw risgiau i sefyllfa ariannol y cyngor. Cytunwyd i'r Cadeirydd ynghyd â Chadeiryddion pob un o'r 3 pwyllgor gyfarfod a chytuno ar ofnion y Cyngor ar gyfer 2026/27 ym mis Hydref cyn gosod y gyllideb flynyddol.</p> <p>Roedd aelodau'n teimlo nad oedd gwneud dim yn opsiwn. Nid oeddent hefyd eisiau rhoi dyled drwm i'r cyngor pan fydd y benthyciad PWLB blaenorol yn dal i'w ad-dalu. Cytunwyd ar y risg o leihau'r Gronfeydd Cyffredinol yn is na'r 25% a argymhellir yn y flwyddyn gyntaf pe bai unrhyw gostau annisgwyl yn codi a bod yn rhaid gwneud rhai dewisiadau anodd dros wariant yn y dyfodol nes bod y cronfeydd wrth gefn yn cael eu dychwelyd i'r lefel briodol. Cadarnhaodd y clerc fod arian wrth gefn wedi'i gynnwys yng nghyllideb 2025/26 a fyddai'n mynd tua cwrdd ag unrhyw gostau annisgwyl. Roedd aelodau hefyd yn teimlo'r angen i hyrwyddo gosod allan y pafiliwn er mwyn gwneud y mwyaf o incwm.</p> <p>PENDERFYNWYD cymeradwyo Opsiwn 2 h.y. ariannu'r tendr isaf o £32,100 a chyflwyno cais am fenthyciad PWLB o £10,000 dros 10 mlynedd gyda chyfradd ad-dalu sefydlog o 5.07% ar gost o £1,240.02 y flwyddyn.</p> <p>Prop/Sec: KT / CT Cytunodd yn unfrydol.</p>	<p>It was noted that the loan repayments to be funded from burial fees were possible in order to avoid any increase in the precept.</p> <p>It was noted, despite being impossible to accurately predict, that approximately 8 burials a year were required to repay the loan. Members also noted the growing trend for cremation rather than burials. It was agreed that the burial fees need to be reviewed in line with budget setting and that all other council liabilities had to be considered. The clerk advised the importance of reviewing all assets, setting appropriate maintenance plans when setting the annual budget and having a contingency included in the budget to ensure an appropriate level of reserves is in place to mitigate any risks to the council's financial position. It was agreed for the Chair plus the Chairs of all 3 committees to meet and agree the council requirements for 2026/27 in October prior to setting the annual budget.</p> <p>Members felt that to do nothing was not an option. They also did not want to burden the council with a heavy debt when the previous PWLB loan is still to be repaid. They agreed the risk of reducing the General Reserves to below the recommended 25% in the first year should any unforeseen costs arise and that some hard choices had to be made over future expenditure until the reserves were returned to the appropriate level. The clerk confirmed that a contingency was included in the 2025/26 budget which would go some way to meet any unforeseen costs. Members also felt the need to promote the letting out of the pavilion to maximise income.</p> <p>It was RESOLVED to approve Option 2 i.e. to fund the lowest tender of £32,100 and to submit an application for a PWLB loan of £10,000 over 10 years with a fixed repayment rate at 5.07% at a cost of £1,240.02 per annum.</p> <p>Prop/Sec: KT/CT Unanimously agreed.</p>
