Accept update regarding Car Park

Cllr. K Taylor provided an update following his recent meeting with Marc Jones, Section 151 Officer at Isle of Anglesey County Council.

- Former toilet building – It was confirmed that no rates are payable on the building due to its low rateable value and the fact that it is currently vacant. It was noted that four parking spaces are included in the agreement for the former toilet building, but they are available for community use while the building remains vacant.
- EV charging – Two parking spaces have been allocated for this work, which forms part of the County Council's Plan for all car parks.
- Recycling bank – The provision of this recycling facility is part of the original agreement for all Isle of Anglesey County Council car parks, as also part of the County Council's Plan.
- Car park rates – It was confirmed that no discount is available to the Community Council.

It was noted that Isle of Anglesey County Council requires six months' notice to terminate the current agreement. The Community Council will continue with the agreement for the coming year and will continue to review the cost annually.

It was reported that the installation of bicycle parking spaces has now been completed.

Thanks were extended to Cllr. K Taylor for his time and effort in painting the millennium benches and also for repair work to the wall in Parc Mwd.
