- Pavilion Fire Risk Assessment
It was reported by the Chair that the Fire Risk Assessment had been undertaken earlier in the month.
The Chair to conduct regular checks in order to comply with statutory requirements.
Fire drill – it was decided not to hold a fire drill due to health and safety risks, as outside of the building was in total darkness.
Emergency Light Testing – it was reported that the emergency light in the boiler room needed repairs, additionally the chair had recognised a number of electrical issues that requires attention. The chair to list all the required electrical work in order to receive quotes from electrical companies.
- Outside Lights
The lack of outside lights outside the pavilion was discussed.
Concerns were raised that lighting may attract more vandalism, but concerns were also raised that the lack of lighting poses a health and safety risk to those using the pavilion as the outside area is in total darkness.
The possibility of arranging a light that need to be switched on manually rather than one that comes on via a sensor was discussed.
It was agreed to look into the light requirements for the pavilion, and to receive quotes for the work before the proposed expenditure 2026/27 meeting, and also to deputise the decision regarding the suitable location of outside lights with the Chair of the Parks Committee.
- Quotes for football field stiles and footbridge repairs update
An estimate was received by BGR Joinery for the stile repairs, repairs to wooden bridge and dismantling the wooden picnic

It was proposed and unanimously agreed to remove the stiles rather than repair them.

It was noted that BGR Joinery has carried out emergency work to secure a picnic bench due to safety concerns if moved picnic table was used to access the roof of the pavilion building. Work priced at £60. Work was arranged following contact between the Chair of the Council, Chair of the Parks Committee and the Clerk.

- Main gate repair update
It was reported by the Chair that G&R Building and Landscaping is currently in the process of carrying out this work now, the work is expected to be completed tomorrow 31/10/2025.
