The Finance and Personnel Committee made the following recommendations to the Council:-

Recommendation 1:

To approve the draft breakeven budget of £77,432.57 for 2026/27.

Recommendation 2:

That the Community Council set a precept of £68,100.79 for 2026/27. This will ensure that we meet any inflationary increases on existing commitments and maintain a breakeven budget for 2026/27.

Recommendation 3:

To approve a minimum and maximum operational reserve for the Council, i.e. minimum 3 months operational cost to a maximum of 100% of the budget.

Recommendation 4:

To approve that Ynys Wen Cemetery account be ringfenced for costs associated with the maintenance and upkeep of the cemetery, but the funds may be accessed as a short-term measure (e.g. large VAT payments, until the VAT has been reclaimed), subject to the agreement of the full council.
