The Clerk presented the draft Budget and Precept Setting Report for the financial year 2026/27. Members considered the projected income and expenditure, the proposed budget allocations, and the financial implications for the Council's reserves.

Following the Clerk's presentation, the Chair of the Finance and Personnel Committee, Cllr G Browne MBE, provided a summary of the report's findings and financial implications.

Having considered the report in full, and having the opportunity to discuss the report, to ask questions or offer observations, the members moved to resolve the four recommendations:

1. **Resolved:** That the Council approves the draft breakeven budget of £77,432.57 for 2026/2027.

2. **Resolved:** That the Community Council set a precept of £68,100.79 for 2026/27. This will ensure that we meet any inflationary increases on existing commitments and maintain a breakeven budget for 2026/27.
