Condition of the Local Area

The Clerk reported that, following the concerns raised at the last meeting (274/2526.2 – decision 1), a response had been received from the County Council's Building Control Service regarding the former commercial property on Station Road, a copy of response has already been shared with the members. The Building Control Officer confirmed that the site has been subject to periodic monitoring, with inspections undertaken in March 2025, November 2025, February 2026 and again this month. Although the building is unsightly, it is not considered a dangerous structure under Section 77 of the Building Act 1984. Heras fencing and protective boarding have been installed by the owners, and as the building is set back within its own grounds, it does not pose an immediate risk to the public.

No formal enforcement action has been taken as the property does not meet the threshold for intervention under Section 77, but periodic monitoring will continue.

Concerns about rubbish on the site have been referred to the Environmental Health team and a response is awaited.

The Clerk informed members that a local resident had recently contacted the Council to raise concerns about the condition of the former commercial property on Station Road (as discussed above) and the adjacent building. The resident has also been in correspondence with the Local Member, Cllr G. Jones, who has already provided them with updates received from the County Council.

Members acknowledged that the Community Council has no statutory authority over the condition of privately owned buildings. The health and safety concerns raised by the resident have already been passed to the County Council by Cllr Jones, as the relevant authority. A copy of the County Council's response to the Community Council will be shared with the resident for their information.

The Community Council is unable to take any further action at this time, however, any additional concerns relating to safety can be forwarded to the County Council for their attention.

The Clerk also informed members that, further to the concerns raised at the last meeting (274/2526.2 – Decision 2), and in accordance with the Council's instruction, a letter had been sent to the owner of the other vacant property on Station Road requesting clarification of their intentions for the building. No response has been received to date.

Condition of Bryn Afon Road

It was noted that since the last meeting, Cllr Taylor had shared details and images of the road condition with the County Council's Highways Department, and that one pothole has since been filled.

Cllr Swaine-Williams requested that Alun Roberts of the County Council's Highways Department be invited to attend a site visit to assess the condition of the road further.

The Clerk shared her serious concerns, together with those of the Chair of the Parks Committee, regarding the deteriorating and unsafe condition of the surface beneath the cradle swing at Parc Mwd. Photographs of the damaged area were viewed by the members.

The Clerk and the Chair of the Parks Committee had obtained four quotations for grass-mat surfacing and two quotations for wet-pour surfacing to inform options for replacement.

The Chair of the Finance Committee enquired about financial planning for the works. The Clerk explained that budget monitoring to Month 11, alongside projected end-of-year expenditure, indicated sufficient underspend to cover the proposed works, with a surplus still available for transfer to reserves.

Members discussed the condition of the site and the options and costs presented.

The Chair thanked the Chair of the Parks Committee and the Clerk for obtaining the quotations.

Resolved: to proceed with replacing the surface beneath the cradle swing at Parc Mwd, awarding the work to Holyhead Town Council at a cost of £1,872.40, and requesting that the swing be secured with Heras fencing as soon as possible.
