Welcome and Opening Remarks

The Chair noted that he wished to pay tribute to the late Councillor Ken Taylor, following the sad news of his sudden passing, who had served the Council since his co-option in June 2013 for almost 14 years.

He was remembered as a dedicated and highly respected member, with clear views and a willingness to speak up in the interests of the community, particularly on matters relating to finance and local facilities. He served as Vice-Chair (2018/19) and as Chair until 2021, leading the Council through the challenging period of the Covid-19 pandemic.

His strong support for the Welsh language and his commitment to the local community were also recognised. Thanks were expressed for his significant contribution over the years, and sincere condolences were extended to his family and friends.

Councillor Gwilym Jones also spoke in tribute to the late Councillor Ken Taylor, noting that he had known him for many years and had worked closely with him since they were elected to jointly represent the Bro Llynnoedd ward in 2022.

He was remembered as an individual with strong views, who was professional and fair, and was held in high regard by colleagues. His valuable contribution to the work of the County Council was noted, particularly as Chair of the Planning Committee, as well as his strong commitment to his community and to Valley.

He expressed his personal sadness at the loss of a friend and colleague.

Councillor Mavis Swaine Williams also paid tribute to Councillor Ken Taylor, endorsing the comments made by the Chair and Councillor Gwilym Jones. She noted that she had known Ken for a number of years through their work on the Council. He will be greatly missed as both a Councillor and a friend.

The Chair expressed his thanks to Members for their messages of sympathy following the passing of his grandmother.
