Parks Budget Review 2025/26

A review of the Parks Budget 2025/26 was presented, providing an opportunity for new members to receive an overview of the previous year's budget in order to gain background to the work undertaken by the Committee.

Members were given the opportunity to ask questions and request further detail if they so wished.

The information was noted.

Parks Budget Monitoring 2026/27

The Clerk provided a brief overview of the Parks budget monitoring for 2026/27 as at 31/05/2026, including a summary of income and expenditure to date.

Members noted the update.

Parks Committee Terms of Reference

The Terms of Reference were reviewed. Minor amendments were recommended by the Clerk to bring the document in line with Standing Orders, including clarification of the Committee's remit to include responsibility for Council assets, including street furniture such as benches, notice boards, planters, the clock and bus shelters. These were agreed by Members.

Resolved: To recommend the amended Terms of Reference to Full Council for approval.

Parks Maintenance and Repairs Programme

The Parks Maintenance and Repairs Programme was reviewed, and details of outstanding matters were shared with new members.

Members agreed to obtain further quotations for the installation of seven speed ramps at Parc Mwd.

It was further agreed to obtain quotations for fire alarm and intruder alarm maintenance at the pavilion building.

Members noted that Legionella awareness training options should be explored.

Nodwyd y dylid trefnu hyfforddiant Marsial Tân ar gyfer aelodau'r Pwyllgor lle bo angen, yn enwedig o ystyried nifer o aelodau newydd ers y sesiwn hyfforddi ddiwethaf.

Nodwyd y gallai rhai o'r gwaith sydd wedi'i gynnwys yn y rhaglen gael eu hystyried fel rhan o gais grant yn y dyfodol ar gyfer uwchraddio'r pafiliwn.

Nodwyd y bydd angen cymorth gwirfoddolwyr yn ystod y flwyddyn i gyflawni gwaith, gan gynnwys chwynnu ardal y Triangl, peintio'r cewyll a'r gwarchodfeydd ffenestri yn y pafiliwn, ac ailbeintio'r fainc dreftadaeth.

9. **Cyllid Grant – Costau a Chynnigion Prosiectau**

Trafodwyd cyfleoedd cyllid grant a chysylltiedig gostau a chynigion prosiectau.

Nodwyd bod prisiau ar gyfer gwaith o dan grant Balchder yn eich Cymuned gan Cyngor Sir Ynys Mon wedi'u derbyn a'u cyflwyno ar gyfer y Cyngor llawn.

Mewn perthynas â National Grid-Cronfa Cymunedol Penrhos, nodwyd bod angen gwaith pellach ar ddatblygu cynllun ar gyfer gwelliannau i'r pafiliwn.

Nododd Cadeirydd y Pwyllgor fod grantiau ar gael drwy'r FAW ar gyfer datblygu cyfleusterau pêl-droed lleol, i'w hystyried yn y dyfodol.

Trafodwyd y cyfleoedd ariannu Bioamrywiaeth drwy Un Llais Cymru. Awgrymwyd y dylid ystyried ceisio am gyllid ar gyfer arwyddion, blychau nythu, gwyddoniaeth i bobl ac offer cynnal.

Penderfynwyd: i gyflwyno'r awgrym i ymgeisio ar gyfer cronfa Bioamrywiaeth Un Llais Cymru, ar gyfer arwyddion gwybodaeth, blychau nyth, gwybuddoniaeth i bobl ac offer cynnal i'r Cyngor Llawn ar gyfer penderfyniad.

It was noted that Fire Marshal training should be arranged for members of the Committee where required, particularly in light of a number of new members since the previous training.

The condition of the Triangle area was discussed. It was noted that the area requires weeding, that there had been a limited response to requests for volunteers, and concerns were raised that weed treatment may not have been undertaken by the contractor. It was agreed that the matter requires further attention and action.

It was noted that some of the works included within the programme may be considered as part of a future grant application for potential upgrades to the pavilion.

It was noted that volunteer assistance will be required during the year to undertake essential works, including weeding at the Triangle, painting of the cages and window guards at the pavilion, and repainting of the heritage bench.

Grant Funding – Costings and Project Proposals

Grant funding opportunities, associated costs and project proposals were discussed.

It was noted that quotations for works under the Pride in Your Community grant from the Isle of Anglesey County Council had been received and ready to be submitted to the full Council.

In relation to National Grid Penrhos Community Fund, it was noted that further work is required to develop a scheme for improvements to the pavilion.

The Chair of the Committee noted that grants are available through the FAW for the development of local football facilities, for consideration at a future date.

Biodiversity funding opportunities through One Voice Wales were discussed. It was suggested that funding be considered for signage, nest boxes, citizens science and maintenance equipment.

Resolved: To submit the proposal to apply for the One Voice Wales Biodiversity Fund, for information signage, nest boxes, citizens

science and maintenance equipment, to Full Council for decision.

Adroddodd y Cadeirydd fod cwynion wedi'u derbyn ynghylch baw cwn ym Mharc Mwd.
- Nodwyd y byddai angen gwybodaeth bellach er mwyn adrodd y mater i Warden Cwn y Cyngor Sir.

Parks Matters

- a) Football Tournament**
The football tournament, to be held the following weekend, was discussed briefly. Charging arrangements were considered, and the Clerk advised that Full Council had previously resolved that charges be applied in accordance with the advertised hours for the event. The Clerk will issue an invoice accordingly. The matter was noted.
- b) Friends of Parc Mwd**
An update was received on Friends of Parc Mwd. It was noted that a poster had been recreated and shared by Medrwn Môn during Volunteers' Week, however the response had been disappointing.
- c) Pavilion Key**
It was noted that Council property had been returned to the Clerk, via the Chair of the Parks Committee, by the family of the late Councillor K Taylor.
- d) Vandalism Damage**
The Chair reported on recent vandalism at the Park, including damage to a bridge, bench and downspout. The matter was discussed and noted.
- e) Dog Fouling**
The Chair reported that complaints had been received regarding dog fouling at Parc Mwd.
- It was noted that further information would be required in order to report the matter to the County Council Dog Warden.
- Members were reminded that contact details for the Dog Warden had previously been circulated by the Clerk.
- f) Container**
It was noted that the Clerk is awaiting further correspondence regarding the container and will report back in due course.

- g) Polion y Bont**
