The Council noted the vacant seat following the passing of Cllr K. Taylor. The first public notice of the casual vacancy has been issued on 15 June, with a closing date of 3 July. In the event that no request for an election is received, the Council will proceed to advertise the vacancy for co-option.

The Chair noted that the closing date for co-option may fall during August when no Council meeting is scheduled, and that all applications should be submitted to the clerk until the next meeting following the closing date.

National Grid – Penrhos Community Fund

The Clerk informed Members that information had been received verbally from Penrhos Community Fund officers that a public report, based on data gathered from the recent fund survey, will be published in the coming weeks. It was noted that the fund will be administered by a third party and is expected to open for applications in September 2026.

Members noted that potential projects had already been identified following the recent ideas session. The Clerk encouraged Members to continue developing their proposals in preparation for the fund opening.

It was also suggested that a further ideas session be arranged following the publication of the Penrhos Community Fund report.

It was noted that Cllr W. Rogerson reported an incident involving the failure of traffic lights associated with the National Grid Penrhos works on the Cob on the afternoon of 13 June. He confirmed that he had contacted National Grid, who acknowledged the issue and advised that actions are being taken to improve the situation.

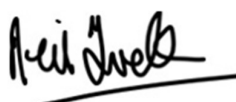
