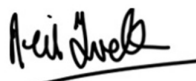

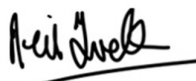

At the outset of the presentation, National Grid representatives expressed their condolences following the recent passing of Councillor Ken Taylor and acknowledged his significant contribution to the Valley community and communities across Anglesey.

The Council received an update on the Penrhos Substation project, including progress to date, forthcoming construction activities, traffic management arrangements and the current completion date of July 2028. An update was also provided on the Penrhos Community Fund, including progress towards the appointment of a fund administrator and themes identified through the recent community engagement exercise.

Members raised concerns regarding construction vehicles obstructing private driveways and increasing HGV traffic through the village. It was requested that contractors be reminded of the 20mph speed limit and that alternative routing via Holyhead be considered where possible. National Grid representatives were also advised of the planned Network Rail closure in January 2027, which would require replacement bus services to use the Stanley Embankment.

Questions were raised regarding out-of-hours traffic management arrangements and the anticipated duration of the proposed Gorad Road closure. The concerns raised were noted by the representatives.

The Chair thanked the representatives for their attendance and update, following which they left the meeting at 7.37pm.
